## **GIFT AID**

To Increase Your Subscription 25% Without It Costing You A Penny, Read On.

If you are a UK taxpayer and you make out a Gift Aid in favour of the Group your subscriptions would be worth 25% more to the group.

It works in the following way, once you have made out a Gift Aid the group can claim back the tax you have paid on the gross amount of your subscription i.e. a subscription of £8.00 would have been worth £10.00 before tax. The £2.00 you have paid in tax can be claimed back by the group; hence your subscription would be worth another 25% to the group. If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return. So come on all you tax payers fill out the Gift Aid form below and help the group by increasing its income and yourselves by keeping subscription increases to an absolute minimum.

PLEASE REMEMBER THE ABOVE ONLY APPLIES IF YOU ARE A UK TAXPAYER.

If you have already made a Deed of Covenant in favour of the Group then making a Gift Aid to the Group would make our administration much simpler.
